## COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court adopt a Resolution nominating up to five (5) candidates for positions on the Tarrant Appraisal District (TAD) Board of Directors.

#### **BACKGROUND**

The current terms of the five (5) appointed members of the TAD Board of Directors will expire on December 31, 2024. Nominations for directors must be made in an open meeting of the voting entity, through a written resolution, and submitted to the Chief Appraiser no later than October 14, 2024.

Each voting entity may nominate one (1) candidate for each of the five (5) positions to be filled. Therefore, the County may nominate up to five (5) individuals, but there is no requirement to make any nominations.

Attached is a letter from the Tarrant Appraisal District outlining this procedure and the number of votes allocated to each taxing entity along with the resolution for Court consideration.
